Lôn St Ffraid – amend existing 60 minutes limited waiting bays to 20 minutes similar to the bays near the Spar shop

Lôn Towyn Capel – proposed double yellow at pinch point

Lôn Isallt – RNLI Station - proposed zig-zag keep clear markings

Lôn Isallt – measures to prevent parking on the grassed area to the back of the pavement (by Parc Isallt)

### 10. COUNCILLORS' REPORTS

### 10.1 Cllr. Bill Rowlands

i. Confirmed his decision to step down as a Community Councillor and wished the clerk and his fellow councillors well for the future. The Chairman expressed his regret at his decision and took the opportunity to thank him for all the work he had done for the good of the community during his term of office. His efforts had been very appreciated and he will be missed.

### 10.2 Cllr. Anwen McCann

i. Reported on her meeting with the Holy Island Landscape Partnership – a number of local heritage sites e.g. the towers by the Trearddur Bay Hotel and Snowdon View Road (those on private land were excluded for now), the Old Coast Guard House in Porthdafarch, the Millennium Cross, the Trearddur Bay Sign etc would all be documented and included on trail maps and apps. to raise public awareness. The Bangor University Maritime Department were taking photographs of all the ship wrecks in the area, this information would also be made available on an app. so the public can view them.

ii. Asked that the benches be painted as soon as possible

iii Reported that the appearance of the gate at Craig y Môr was still of concern to residents. County Councillor Trefor Lloyd Hughes said that vehicles were not allowed beyond the gate because that section formed part of the coastal path and that all bar disability vehicles were prohibited on that.

### 10.3 Cllr. Geoff McGinn

i. Asked for an update on the developments taking place at Glasfor and at the Old Cottage Isallt Fawr.

### 10.4 Cllr. Dafydd Rhys Thomas

i. Had received a petition and official request from local residents for double yellow lines, appropriate signage etc. to prevent the large number of campervans that were parking overnight on Lon Isallt. This had been referred to the County Council and would hopefully support the Community Council's request for a resolution to this problem.
