9. COUNCILLORS' REPORTS:

9.1 Councillor Bill Rowlands

Unfortunately the 'Village Litter Picking' event had not been well supported however, 15 large bin bags of rubbish and 8 bags of polystyrene had been collected. Huge amounts of polystyrene were found to be floating into the bay from the destroyed Pontoon in Holyhead and dog fouling was an increasing problem.

The RNLI lifeboats recovered 5 large polystyrene floats and 3 large bin bags of polystyrene from around the coastline but it was apparent that this was a major problem for the whole area.

The surplus sand had been removed from the eastern side of the promenade.

9.2 Cllr. Eric Roberts

The Village Hall Committee had complained to Trading Standards about the company who provided the curtains as they had failed to address the faults that were appearing in the blackout fabric. Concerns had also been raised about the storage/misuse of equipment.

13.1 Beach Clean-up

The amount of polystyrene still being washed up on the beaches following the destruction of the pontoons at Holyhead Marina on 7th March was still a major problem. IOACC Staff, Biffa and an army of volunteers had worked hard to clear the tons of debris. Concerns were raised about salvage operations, why the debris wasn't contained etc. The environmental impact could be disastrous and the lack of support from the Welsh Assembly was very disappointing.
