on the play area, the clerk would arrange for quarterly inspections by a suitably qualified person. The annual check would be done by Zurich.

The clerk would contact the contractor about cutting the grass, arrange for the bins to be emptied every three weeks and obtain prices for new signage.

## 8. COUNCILLORS' REPORTS:

#### 8.1 Cllr. Keith Roberts

The Burial Board Agreement of 1974 had been rewritten and the proposals should save approximately £10,000 per annum, this will be reflected in the precept.

He had spoken to representatives from the Sailing Club and was under the impression that the new development was to be used as a Club House.

A complaint had been made about the tip on the Bagnall site, and this had been dealt with immediately.

The Council also noted that the Bagnall Caravan site had changed their lights to LED.

## 8.2 Cllr. Geoff McGinn

Reported that the posters and banners that had been put up in various places in the village were making the place look untidy. Arrangements were to be made for these to be removed.

The path and wooden steps down to the beach from Henborth had been washed away. The problem was to be reported to IOACC.

Requested an update on the planning on Craig Eithin, Lon St Ffraid.

## 8.3 Cllr. Dafydd Rhys Thomas

Said the double yellow lines should be extended to help the parking/ traffic situation in the village. Resolved that the clerk would contact IOACC asking for the double yellow lines to be extended:

1. from the Lon St Ffraid junction towards the village hall as vehicles were still causing a hazard by parking too near to the junction

2. to beyond the dropped kerbs by the entrance to the cricket ground as parked vehicles were restricting wheelchair users etc.

The signage needed to be changed to reflect the new restrictions.

## 8.4 Cllr. Susan Conrad-Smith

Said that the lights from the Premier Inn can be seen from the Range, they were detrimental to the area. This was a matter for the Holyhead Town council as the

Premier Inn was in their area.

Reported that the wall by Cassetta, Lon Isallt had collapsed, possibly due to coastal erosion. The clerk was to report this to Natural Resources Wales.

## 8.5 Cllr. Anwen McCann

Had received complaints about the flood lights by Ty'n Ffrwd, Cllr. D. Rhys Thomas had spoken to the owner and that matter was resolved.

Reminded the Council that the benches and footpaths required attention. The clerk would contact the contractor.

## 8.6 Cllr. Bill Rowlands

Informed the Council that the local PCSO would be coming to the next meeting – a 6.30 pm start was agreed by all.

The Trearddur Bay Sailing Club will be celebrating its Centenary this year, a book detailing its history is for sale at Trearddur Stores for £20.

## 8.7 Cllr. Eric Roberts

Reported that the defibrillator had now been put up by the Village Hall.

Work was continuing to bring Wifi to the hall.
