8. **PLANNING MATTERS – applications** circulated by email

8.1 **HP/2020/ 99 Larkfield, Lon Towyn Capel, Trearddur Bay -**Full application for alterations and extensions – no objections.

8.2 HHP/2020/87 23 Hunter's Chase, Trearddur Bay -

Full application for the retention of the height of the replacement garage roof together with the erection of a boundary fence/wall – no objection.

8.3. Planning Consultation FPL/2020/41 Porth Diana Boat Yard, Ravenspoint Road, Treaddur Bay, Holyhead

Full application for alterations and extensions to an existing building to provide an enclosed meeting and event space, bar and servery allied with internal modifications to provide improved toilet facilities for the sole use of the sailing club/boat yard (sui generis)

Resolved to reiterate the objections made in March 2019 when the original application was submitted i.e.

Access: is up a dead end lane leading to residential properties and is very narrow with no room for manoeuvre.

The boat yard entrance is on a blind bend

This lane forms part of a public footpath that is used extensively by families as a route down from the caravan sites to the beach.

Parking:

The application does not include a provision for parking and any attempts at parking on any part of this lane or indeed anywhere else in this vicinity will cause gridlock.

Impact on residents:

The impact of the noise emanating from holding social events on this site (on up to 7 evenings a week all year) would be intolerable and likely to have a huge detrimental impact on neighbouring properties. Late night revellers are rarely considerate and residents are extremely concerned about the potential loss of privacy and quiet enjoyment of their homes.

No community benefit:

The development is of no benefit to the community.

It was also agreed that the supporting evidence included in Technical Note VAL/DR/190491/TN01 - 23 December 2019 should be challenged as the traffic survey that was carried out to support the application was not independent and not representative.

"The survey conducted last year to monitor the traffic and pedestrians accessing Porth Diana lane – which was used to 'prove' that their current clubhouse wasn't adding traffic to the area, did in fact take place on an August weekend. However, as it was their centenary year, they had a marquee in Druidsmore field, further up

Ravenspoint Road which they used all summer for their social events, so no extra traffic showed up on the lane, unsurprising really, as it wasn't being used!"

The Community Council would therefore ask that the Highways Department reconsider the site access and that the application be 'called in' for further consideration.
