The Zurich Playground Annual Inspection had identified minor faults with the swings and MacVenture Play had carried out the repairs. The loose pin on the Black Basket Swing was said to be a manufacture problem and MacVenture Play were actively pursuing the manufacturer for a replacement.

The contractor had cut the grass and Cllr. Bill Rowlands, Cllr. Stephen Magee and the clerk had prepared Covid-19 signage etc in preparation for the re-opening on 21 July 2020.

The Chairman was very keen to have a notice board put up in the play area the clerk would obtain prices for a post mounted weather proof board.

#### 10. COUNCILLORS' REPORTS:

#### 10.1 Cllr. Bill Rowlands

Reported that the zebra crossing markings by the Lifeboat Station needed repainting.

#### 10.2 Cllr. Geoff McGinn

Expressed concerns that the work on the double yellow lines and dropped kerb by the Old Cricket Ground and the double yellow lines from the junction on the Lon St Ffraid towards the village hall was still not complete.

#### 10.3 Cllr. Keith Roberts

Asked about the possibility of having temporary restrictions to control the number of vehicles parking by the chapel on Lon St. Ffraid, buses were unable to get through etc.

#### 10.4 Cllr. Paula Parry

Reported that Church Warden had had to close the gate to the church yard to prevent visitors from parking there.

# 11. CORRESPONDENCE - circulated for information only

### 11.1 Anglesey awards new waste collection and cleansing contract)

The new eight-year contact with Biffa (the existing contractor), with an option to extend, will begin on April 1st 2021 and follows an extensive tendering process. The new contract is worth £40m over the initial eight-year period.

#### 11.2 Parking Trearddur Bay

Request from a member of the public for more double yellow lines as some cars were exceeding the time limit on Lon St Ffraid. It was agreed that this was an enforcement matter.

Complaint also received from a disabled resident that they are not able to see the beach when parked in the disabled bay by the Life Boat Station as the large sign was blocking the view.

It was noted that indeed the large information board does block a lot of view down the promenade from that particular spot, but the disabled bay had been placed

### 11.4 Awel y Môr Offshore Wind Farm

Notification that permission was granted by The Crown Estate in October 2019 to extend the existing Gwynt y Môr Offshore Wind Farm with the agreement for a lease for the <u>Awel y Môr Offshore Wind Farm</u> (it's 'sister' project). They were working towards becoming operational by 2030.

11.5 Survey off Remote Working – the clerk would respond to this.
