Application under Section 73A for the variation of condition (05) (details of materials) (06) (details of fencing and walls) (07) (Construction Traffic Management Plan) from planning permission 46C410H on adjacent land – no observations.

8.2 S106/2020/2 Cae Glas landfill tip area, Holyhead.

Submission of site investigation, laboratory assessment, remediation strategy and risk assessment to comply with the Terms of Agreement as set out in part 5 of Schedule 8 of the Section 106 Agreement attached to planning permission 46C427K/TR/EIA/ECON – The fact that the site investigation report requested as part of the NRW recommendations was commissioned and paid for by Land and Lakes was met with some misgiving. Members continued to be concerned about the potential contamination and felt that the developers were being allowed to discharge its responsibilities.

9. PLAY AREA

There had been criticism from some members of the public that the play area was still locked but the Welsh Government directive was that it should remain closed until further notice. In the meantime, the grass had been cut and McVenture Playgrounds would be replacing the links on the junior swings.

10. COUNCILLORS' REPORTS:

10.1 Cllr. Bill Rowlands

Reported that the COVID-19 Volunteers were continuing to support those who are self-isolating but numbers are dropping as the big stores were improving their delivery services.

A Food Bank Collection Box had been set up in the entrance to the Village Hall, this was well supported by the Community - many thanks to all concerned.

10.2 Cllr. Stephen Magee

Reported that a safety fence on the coastal path between Trearddur Bay and Rhoscolyn was very corroded and dangerous. The clerk would report this to IOACC.

10.3 Cllr Keith Roberts

Reported that he was still assisting local residents with prescriptions and shopping.
