4. MATTERS ARISING FROM THE MINUTES

4.1 The contractor had been asked to cut the footpaths by Isallt Fawr and from the Spar shop down towards the beach.

Submitted and confirmed the financial report for the period to 30.6.2021 together with bank reconciliations and statements.

7. PARKING

The massive influx of people had compounded the problems with parking in coastal villages all over the island but the parking problem was only one of a number of issues that needed to be resolved in Trearddur Bay. It was agreed that an extra ordinary meeting should be arranged with officers from the relevant departments of the County Council to discuss parking, enforcement, local by-laws, waste management, toilets etc. after the end of the summer season.

8. PLAY AREA

The ropes for the log climbing frame were on order. The Council had been let down by Veolia but the clerk had arranged for Humphreys Recycling Ltd. to collect the waste on a weekly basis. The total charge for the provision of the bin and emptying it was £12 per week.

The Playground Inspector was submitting his report to the clerk on a weekly basis.

10. COUNCILLORS' REPORTS

10.1 Cllr. Bill Rowlands

Had attended the Town and Community Council Liaison Forum (virtual meeting). The topics for discussion included: Covid-19, Council Tax Premium for second homes and 2022-27 Housing Strategy. Unfortunately, the translation process was poor and he missed part of it, but the minutes would be distributed shortly.

He also reported that the County Council had replaced two bins, one by the spar shop the other by the slipway.

10.2 Cllr. David Williams

Residents on Lon St Ffraid were being troubled with rowdy teenagers walking back to Holyhead in the early hours of the morning. This would suggest that local youths were a causing these problems. The PCSO would be notified.

10.3 Cllr. Parry

Reiterated her concerns about the number of motorists still ignoring double yellow lines on Ravens Point Road, but it was good to see that a number of them had received tickets because of the increased presence of County Council enforcement officers.

10.4 Cllr. McGinn

Had been approached regarding the campervans parking in the layby by Bay View, Lon Isallt, they were leaving rubbish and emptying their toilets on the beach. As many as 50 campers were parking all along Porthdafarch Road towards the Range and beyond towards South Stack. He asked for more signage on the roadside to try and deter them.

10.5 Cllr. Conrad Smith

Echoed his concerns saying that emptying human waste above the high tide mark was a serious environmental health issue.

10.6 Cllr. Eric Roberts had managed to get some to move, they had parked up for the night and were emptying their toilets down a drain at Porth y Post. When they saw him take

photographs of their vehicle registrations etc. with a view to reporting them for trespass they left. He would be putting his own signs up there as he owned that stretch of wall.

10.7 Cllr. Dafydd Rhys Thomas

Said the issues raised above and the recent problems with jet skis should to be included in discussions with the County Council (as per item 7).

He also made reference to the recent Land and lakes consultation document and the fact that Plot 9 – the truck stop was to be used by Border Control. An alternative site would have to be found for the trucks.

Reported that the County Council had received additional funds and that he was pushing for this to be spent on public conveniences. This raised a question about those facilities that had already been transferred to Community Councils.

Cllr. Bill Rowlands complained that Trearddur Bay toilets needed serious attention, one entrance had been closed off to create a shower area that had never been used. The facilities were limited and nappies etc were being left outside the building.

Cllr. Keith Roberts

A number of residents were concerned about a new agricultural shed that was in the process of being built at Pen Y Bryn, Lon Crecrist. - DAG/2020/11 referred, it was agreed to request that the site be visited by IOACC planning Officers.
