### 10.3 Cllr. Dafydd Rhys Thomas:

The Anglesey Aluminium chimney had finally been demolished at 2pm that day and crowds had gathered round to watch the event.

The Active Travel Scheme was progressing and roadworks were still in force around the Tesco/ Morrisons roundabout.

The resurfacing work on Raven's Point Road was complete and the work on the pavement opposite the Beach Hotel would be carried out in the new financial year.

He was still pressing IOACC about the outstanding work on Trearddur Road.

IOACC would shortly be installing card payment machines in the car parks in Trearddur Bay, in the meantime he was insisting that a better job be done on making good the surface of the main car park.

IOACC was exploring the possibility of having approved sites that would keep the campervans off the verges, but this was still in early stages.

Smoke free signs had been put up by the beach but only time would tell whether the public take notice of them.

Trearddur Bay Village Hall continued to be well used. The Management was looking for a builder to refurbish the toilets. It was noted that the outside light needed attention.
